If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

EMBALMING \$895

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are made of heavy cardboard and wood composite. Rose Hills Crematory prohibits the use of non-rigid containers.

You also have the right, at any time, to cancel any contract or agreement related to trust-funded preneed cremation services and to obtain a full refund of any amounts you paid, less a revocation fee.
