Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any pre-need agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF \$2,495

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains.)

EMBALMING \$895

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Notice Regarding Trust-Funded Pre-Need Cremation Services:

Under California law, you have the right to purchase trust-funded future (or "pre-need") cremation services, including such services sold as part of a pre-need funeral agreement, without being required to purchase merchandise (such as urns or other keepsake items), travel or relocation protection, or any other packages, plans or other add-ons. If you purchase trust-funded pre-need cremation services, you also have the right to have the amount you paid for such cremation services placed into trust. You also have the right, at any time, to cancel any contract or agreement related to trust-funded pre-need cremation services and to obtain a full refund of any amounts you paid, less a revocation fee.
