Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering), The containers we provide are a fiberboard container or an unfinished wood box.

### New York State Disclosure:

If you want to arrange a direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composition materials (with or without an outside covering), or may be pouches of canvas or other materials

Direct cremation includes the Transfer of remains from place of death to funeral home, Refrigeration, Transfer to or from crematory, Basic Services of the Funeral Director and Staff for Direct Cremation and securing of necessary authorizations.

If you do not want embalming, you have the right to choose an arrangement which does not require you to pay for embalming such as direct cremation or direct burial. If you select certain funeral arrangements such as viewing or an open casket funeral, embalming may be required by the funeral firm.
